This application **MUST** be completed in order to receive a roll-off container free of charge from the Jersey City Incinerator Authority ("JCIA").

THIS SERVICE IS CONTINGENT UPON ADEQUATE FUNDING BEING AVAILABLE IN OUR BUDGET.

You are eligible to receive "Free" roll-off container service if you meet the following criteria:

- ❖ You are a **NON-PROFIT ORGANIZATION** (i.e. block association, civic association or religious organization).
- ❖ The container will be used for community participation **ONLY**, not personal use.
- ❖ The container will be used for general clean-up of properties **ONLY** and not for improvements or rehabilitation of properties/buildings.
- ❖ The container is for Jersey City properties **ONLY**.

THE JCIA MAY ONLY PROVIDE TWO (2) CONTAINERS PER YEAR TO QUALIFIED APPLICANTS.

YOU MUST PROVIDE THE JCIA WITH A LETTER FROM YOUR ORGANIZATION STATING THE INTENDED USE FOR THE CONTAINER ALONG WITH YOUR APPLICATION. This application and your letter must be returned to the JCIA at least one week prior to the date requested in order to be properly processed.

EVEN IF YOU ARE A NON-PROFIT ORGANIZATION, YOU MAY NOT USE THE "FREE" CONTAINER FOR CONSTRUCTION AND DEMOLITION ("C & D") WASTE. IF C & D WASTE IS FOUND IN THE CONTAINER YOU WILL BE CHARGED THE CURRENT DISPOSAL RATE OF \$96.75 PER TON FOR THESE MATERIALS, PLUS A HAULAGE FEE OF \$225.00.

An Environmental Inspector will conduct an inspection of the container while it is still on-site to insure the container is used for the debris specified in this application. If the Inspector finds unauthorized materials in the container it will be pulled immediately and the above fines will be imposed.

Free container service is **NOT AVAILABLE** for organizations engaged in construction, rehabilitation or demolition work or realtors, contractors, developers or any other related businesses.
