Containers are available in three sizes; 10 Cubic Yards, 20 Cubic Yards & 30 Cubic Yards. Please check container size requested:

10 cy = \$435 – includes 2 tons (max.) of solid waste/rubbish

20 cy = \$530 – includes 3 tons (max.) of solid waste/rubbish

30 cy = \$650 – includes 5 tons (max.) of solid waste/rubbish

PLEASE NOTE: ONLY 10 CY & 20 CY CONTAINERS ARE AVAILABLE FOR THE DISPOSAL OF DIRT & CONCRETE.

Containers are rented for a period of three (3) days & include one pick-up & disposal fee. If you fill the container in less time & need it returned, you **MUST** pay for a second container & related disposal fees.

ADDITIONAL FEES

An additional overage fee of \$107.25 per ton will be assessed for containers exceeding the above listed maximum tonnage.

An additional fee of 1/3 of the cost of the container will be assessed for each day a container is kept over the allotted three (3) days:

- \$145.00 for a 10 CY Container
- \$176.66 for a 20 CY Container
- \$216.66 for a 30 CY Container

ACCEPTED METHODS OF PAYMENT

We accept MasterCard &/or Visa as well as a certified check, cashier's check, money order or check card. We do not accept American Express &/or Discover Credit Cards.

If payment is made using a check a credit card is still required to insure the JCIA receives payment for any overages.

A fee of \$32.00 will be assessed if your check bounces or credit card is declined when processing overage fees. This fee will also be assessed on all charge-backs.

Photo identification is required when contract/agreement is signed. A valid NJ State Driver's License is the preferred form of identification.

TERMS & CONDITIONS OF CONTAINER RENTAL PROGRAM

JCIA business offices are open Monday through Friday, from 8:30 A.M. until 3:30 P.M. for container rentals. Containers cannot be rented on Saturday or Sunday, however, containers rented on Wednesday will be picked-up on Saturday & those rented on Thursday will be picked-up on Sunday. If a holiday falls within your contracted rental period the container will be picked-up on the first business day following the holiday.

A PERMIT is required to have a container placed on a city street. This PERMIT must be obtained from the TOWN'S ISSUING PERMIT DEPARTMENT PRIOR to the JCIA dropping a container. If our driver attempts to deliver your container & you do not have the required PERMIT the container will not be dropped, however, you will be charged for the day. _____ (←initials required)

If the container is going to be dropped on private property, not on the street, the owner must sign a release/waiver form.

It is the Renter's responsibility to insure there is adequate space to drop & pick-up the container. ***If our driver attempts to deliver your container & there is not adequate space there is no guarantee we will be able to return the same day to make a second attempt, however, you will be charged for the day.*** _____ (←initials required)

The Renter is responsible for any & all waste put in the container while in their possession. _____ (←initials required)

If additional costs are incurred & full payment is not received within thirty (30) days, the JCIA will pursue legal action. _____ (←initials required)

If you complete your work in less than the three (3) days allotted under this contract, contact Aretha Martin at 201-432-4645 ext. 620, Monday through Friday or Security at ext. 614 on the weekends to make arrangements for the container to be picked-up early. ***If you are unable to reach Aretha Martin at ext. 620, call the JCIA main number 201-432-4645 ext. 600 & the operator will direct your call.***

Credit Card Agreement
